# Professional Experience Program in New York

# CALL FOR APPLICATIONS 2025



The program will take place in spring/summer 2025.

Call for Applications: June 13, 2024 (publication date)

Application Deadline: August 11, 2024
Duration of Program: 1 week + 3 months
Skills Seminar in NY: April 28 – May 2, 2025

The internship is expected to start after the skills seminar week on May 5, 2025. Internships can also be

shorter or longer, depending on the needs of the internship provider and the students.

#### About PEP in NY

The Professional Experience Program (PEP in NYC) is managed by the Campus OWL liaison office in New York City and intended for students from the five Campus OWL universities (Bielefeld University, Paderborn University, Hochschule Bielefeld – Bielefeld University of Applied Sciences and Arts, OWL University of Applied Sciences and Arts, Detmold University of Music).

PEP in New York City offers students the chance to gain intercultural skills and professional experience in the United States. The program includes a skills seminar week in New York City, an internship in a company/organization in the New York metropolitan area (or other locations), and a virtual workshop to reflect on the experience.



#### Requirements

- Enrolled as a full-time student at one of the universities in OWL (Bielefeld University, Paderborn University, Hochschule Bielefeld – University of Applied Sciences and Arts [HSBI], OWL University of Applied Sciences and Arts [TH OWL], and Detmold University of Music) for the summer semester 2025
- At time of application (summer semester 2024), enrolled full-time in a Master program or at least in 3<sup>rd</sup> semester Bachelor program
- Good academic performance
- Very good command of spoken and written English (B2 at a minimum)

# **Application Documents**

- Letter of motivation including how the program helps you to achieve your goals and how it relates to your studies (in English, 1 page). Please refer to the letter of motivation template provided on the website <a href="https://www.campus-owl.org/owl-students/">https://www.campus-owl.org/owl-students/</a>. All generated letters of motivation will not be accepted.
- Resume including education, work experience, skills, previous scholarships/awards, and other relevant experiences such as volunteer experience (no photo necessary; in English)
- Copy of your transcript of records (providing an overview of your previous academic achievements with grade average; copy of bachelor's degree, if applicable)
- Letter of recommendation written by a professor/lecturer of your faculty (this recommendation letter
  can also be used for the internship application and J-1 visa application; preferably in English). Please
  use the letter of recommendation template provided on the website (https://www.campus-owl.org/owlstudents/).
- Confirmation of enrollment as a full-time student

# Before the Program

**Outline of Application Process** 

- Students must submit their application in a single PDF file to simons@campus-owl.org by the deadline on August 11, 2024.
- Candidates who are considered for the program will be asked at the end of August to submit the "Career Field Profile" document by September 10, 2024. You will find the "Career Field Profile" template on the website <a href="https://www.campus-owl.org/owl-students/">https://www.campus-owl.org/owl-students/</a>.
- Candidates will be notified by mid-September if they are invited for an interview. The interview will be conducted in English only. Interview date is end of September/early October by video call.
- Shortlisted candidates will apply for internships in October December 2024.
- After securing an internship placement, candidates will apply for a J-1 visa in cooperation with the German American Chamber of Commerce in New York and the internship provider (January-February).

#### Internship placement

Once accepted to the program (after the interview), candidates will start searching for an internship opportunity. They will get placement support from Campus OWL New York, if needed. It is important that every candidate shows initiative in this process, either by sharing their own ideas for internships or by securing their own internship independently. There is no guarantee that an internship placement will be successful. You will only receive an official offer for a place in the PEP program if you are accepted by an internship provider who will host you. Only a placement in an organization or company will allow you to apply for a J-1 visa for interns.

To host J-1 interns, host companies must have at least 5 employees on site, offer full-time work for the intern (at least 32 hours/week), as well as in-office work at least 3 days per week.

# Visa Regulations

Students who are accepted by the internship provider need to apply for a J-1 visa (J-1 exchange visitor visa for interns). The internship must have a clear relation to the candidate's academic education and must be highly relevant to the future career development and existing background of the candidate. The German American Chamber of Commerce in New York (GACCNY) is the cooperating and supporting partner in the PEP program. GACCNY can sponsor the J-1 visa for internships in a variety of sectors.

However, GACCNY <u>cannot</u> sponsor visas in activities such as teaching, health/medical/social work, in the arts (music, design, theater, etc.), and the government sector.

Campus OWL will support the application process for the J-1 visa by covering the \$900 fee for issuance of the DS-2019 (certificate of eligibility for the J-1 visa). See below under "Funding and Expenses" about additional fees.

# During the program

An intensive 5-day interactive skills seminar will take place in New York City from April 28 – May 2, 2025, and will cover the following key areas:

- Understanding American & German business cultures and navigating differences
- Workplace skills and development with practical exercises
- Exposure to New York City through a cultural program

Campus OWL will cover accommodation in a hotel in New York City, a MetroCard & the cultural program during the skills seminar week.

The internship will start after the skills seminar, on May 5, 2024, and usually lasts 3 months. Shorter or longer internships are possible according to the host company's/organization's and students' needs.

# After the program

After finishing the internship and returning to Germany, the PEP group will meet virtually with the Campus OWL New York office to evaluate the experience and discuss ways on how to make use of the internship for future career planning. Participants are also required to write a report about their internship and what they learned during this time.

# Funding and Expenses

Participants will be considered for a scholarship under the DAAD PROMOS funding scheme or other funding tools for travel and stay by their university. For further information regarding PROMOS and the application process, contact the International Office at your university. Please be aware that living in New York is expensive, and that these funding tools will only cover parts of the expenses abroad. Please also note that many internships in the US are paid.

Participants will bear the costs for the international health insurance (*DAAD Gruppenversicherung, ca.* €40/month) as well as the \$220 SEVIS fee and the U.S. Consulate fee of €160 for the J-1 visa at the Consulate in Frankfurt, Munich, or Berlin. Be prepared to travel to one of these consulates to apply for and obtain your visa in person.
